I suggest the following motion (unfortunately somewhat wordy) be discussed and voted on:

No member of SAVE OUR TRAILS may write a letter or take a stand at a public meeting as a representative of SAVE OUR TRAILS unless the letter or position has been approved by a vote of the Board of Directors. In urgent situations, where the letter should be written or public statement made before the next meeting of the Board, a draft of the proposed letter or statement may be sent by email to all Board Members, and Board Members polled by email. If a quorum responds, and a majority responds affirmatively, then that will be considered as authorization for the letter to be sent or the position statement to be made at a meeting in the name of SAVE OUR TRAILS. However, if two or more Board Members object (even if a majority are in favor), the letter may not be sent and the position may not be taken without majority approval after discussion at a Board meeting.

- c) Vote on whether to write five letters, as requested by Yves Zsutty, in support requests by the City of San Jose for various trial grants. (See Attachment at the end of the minutes.)
- d) Consider the issue of having two kinds of meetings: (a) one for business, meant for Board members only, and (b) one for the general public, where minimal business will be conducted.

The Save Our Trails Organization strongly supports the subject grant application for funds to improve the Tasman Drive trail undercrossing.

Our organization promotes trail development in Santa Clara County for the benefit and enjoyment of all members of the community. Save Our Trails also supports the City Council's Green Vision for development of a 100-mile trail network linked to a 400-mile on-street bikeway system by 2022.

The Guadalupe River Trail is an important core trail within the City's network. Upon full build-out from the Bay to south San Jose, the trail will provide about 20 miles of continuous, off-street trail access linking housing, retail, recreation, and employment. The Tasman Drive undercrossing is located along the trail system, and provides passage beneath a busy arterial roadway with light rail service.

The target project for this grant will offer immediate benefits to pedestrians and bicyclists. Construction of improvements at the Tasman Drive undercrossing will:

- Permit year-round access by elevating the trail above normal tidal flows
- Permit ADA access and better bicycle access by improving the pavement surface
- Address the sole remaining barrier along a trail system that currently extends from the Alviso (San Francisco Bay) to downtown San Jose (about 9.5 miles)
- Support daily commuting along a route that is documented to carry nearly 1,000 daily users (over 50% are bike commuters)
- Offer better access to nearby light rail service
