Speakers for General Meeting

<u>Leslee Hamilton</u>, Executive Director of the Guadalupe River Park Conservancy, spoke on "The Guadalupe River Park and its place in the community"

<u>Larry Ames</u>, Long time trails advocate spoke on "The accomplishments of SAVE OUR TRAILS with regards to the Three Creeks Trail"

<u>Yves Zsutty</u>, Trails Manager, City of San Jose Department of Parks, Recreation & Neighborhood Services spoke on "Overview of the San Jose Trails Program"

Bruce Tichinin, Attorney, SAVE OUR TRAILS spoke on "The acquisition and clean-up of the Three Creeks Trail". Bruce reported that the project to remove soil contamination from the Western Alignment of former Willow Glen Spur Railroad ROW is expected to start in April and run for 10-15 weeks. (The Western Alignment runs from Lonus Avenue, a little north of the trestle, south to Minnesota Avenue.) Notice of the start of the project is expected to be mailed to some 300 nearby property owners in early April.

The City and Union Pacific are presently in negotiations to produce a contract for the purchase of the Western Alignment. The purchase price is around \$7 Million. The City has the required funds. The City's negotiators expect to submit a final form of contract for the approval of the City Council this June, with an anticipated close of escrow on the purchase on the fully- decontaminated property in November.

This March 15, the San Jose City Council is expected to advance a proposal for a \$640,000 study for the design and construction of the entire 3 Creeks Trail (from Lonus Avenue to Minnesota to Kelly Park in East San Jose), a reach of 2.8 miles. The study contemplates that the Trail will open in fully-improved condition (paved with landscaping) in July of 2013. However, it also is anticipated that an interim trail (leveled and with gravel) will open for the Western Alignment shortly after it is purchased this November.

The presentations were followed by a question and answer session.

Results of Vote

After the meeting, the Nominating Committee counted the votes and announced the result: everyone on the ballot received more than the required 15 votes and consequently was re-elected.
