Deferred Issues

We did not have time to discuss the surface of the path on the Three Creeks Trail.

New Issues

a) <u>Request from Don Weden to endorse the "Basic Principles" put forth by the Friends of Santa Clara</u> <u>County's Parks, Trails, and Open Space</u>

Don expressed a concern that Park Charter funds intended for parks and trails of county-wide significance might be misappropriated for neighborhood parks in underserved county areas. He was building a coalition of like-minded organizations to keep Charter funds for the originally designated purpose, and asked that SAVE OUR TRAILS vote to support the following set of Principles:

Principle #1: Consistency with Voter Intent and with County Plans and Policies

The County Parks Charter Fund should only be used in ways that are consistent with:

- a. The Charter Fund ballot language approved by the voters,
- b. The County General Plan's parks and urban development policies
- c. The County Parks Department's Strategic Plan

Principle #2: Countywide Significance

The County Parks Charter Fund should only be used for parks and trails – in rural and urban areas – that are of countywide significance.

Principle #3: Parks Deficient Areas

High priority should be considered for proposed urban parkland acquisitions of countywide significance within or near areas that are parks deficient.

Bruce (via telephone) and Don had an animated exchange on the issues and the politics of the Board of Supervisors. Martin said he felt uncomfortable voting on a potentially controversial issue after hearing only one side of the story. Tai felt that it was important that we talk with Supervisor Shirakawa before taking a stand, and said that she would urgently try to set up a meeting with the Supervisor.

Given the perceived urgency of the issue, the Board agreed to hold a special meeting on the following Monday, November 21st to consider this issue.

b) Consideration of alternatives for handling email list. (Mary Ellen)

We did not have time to discuss this issue. It too will be deferred to the special meeting on Monday, November 21st.

Adjournment

The meeting was adjourned. The next meeting will be on Monday evening, November 21st, at 7:00 pm. Joan said that she will not be able to attend and requested that her absence be excused.
