Disagreement on whether to participate in the trail count,

A suggestion that we should partner with other groups such as the Friends of the Five Wounds Trail, Jack offered to liaison with Larry about the Open Space Authority ballot,

Jack recommended watching the recent San Jose Mayoral debate that took place in Willow Glen, Someone remarked that Bill had expressed on interest in trash cans near trails,

Two board members noted that there are already poop bag dispensers recently installed on the trail, including one north of Willow on the trail.

Mary-Ellen offered to send out info on who to contact at the city about graffiti. See action items.

Martin volunteered to look at agendas of city and county agencies for upcoming meetings about trail issues. See action items.

Martin volunteered to liaison with Yves about getting a San Jose trail on the national Bike Trail map. See action items.

Jack presented a handout from the Open Space Authority on the Santa Clara County Greenprint. He pointed out the references to trails in the brochure. Jack also alerted the group to a recent article in the Willow Glen Resident about a parks fund that has money for projects. Mentioned in the article were Carol Rosen and Helen Chapman.

Yves Zsutty alerted SOT about a small grant available to non-profits from California Trails and Greenways Foundation. See http://www.ctgf.org/grants/. Grant applications posted May 1, 2014, due Sept 30, 2014. Grants have been between \$500 and \$5000, with \$800-\$1000 being most common. Larry offered to brainstorm ideas that would be useful projects.

A letter was received from Jean Dresden on April 4, 2014 detailing what steps we can take to renew two parks rangers. Mary Ellen offered to write letters to send to city councilmembers. See action items.

Martin asked if we need to implement committees again. The group decided to have a committee meeting to decide whether to have committees. Martin offered to coordinate schedules.

Bertha and Larry discussed possible funding from Google related to trails. Larry and Bertha offered to research the situation. See action items.

The group voted on business cards for board president, Bill Rankin. The board unanimously approved the purchase of 100 cards at a cost of \$45.98. Mary-Ellen and Martin offered to split the cost of 100 generic cards for other board members.

Bill requested permission to speak as the president of Save Our Trails at a San Jose City Council meeting regarding extending the Guadalupe trail, as described in the letter written and mailed to the council. The board approved this motion unanimously.
