There was discussion about Martin Delson's email to the board about clearing the trails after big rain events, especially the Guadalupe Creek Trail. Eleni Jacobson talked about what SVBC members are doing to solve the problem and how they can contact city staff. Stephane Maes also discussed how SJCC is involved with cleaning creek trails.
